ORDER

REVENUE ENHANCEMENT PLAN OF DEPARTMENT OF FISHERIES:

Every year the Govt. Fish Seed Farms/Govt. Fish Farms are allotted with a substantial amount of farm maintenance fund and periodically special fund for improvement / up gradation of Govt. Fish Seed Farms/ Govt. Fish Farms by the Government. During the last two financial years, 10 fish farms have been upgraded to Model Fish Farms with an allocation of ₹ 80.00 lakh under State Plan. In addition to state plan allocation, a number of farms have been upgraded under RKVY, CSS (FFDA) assistance. However, the revenue of these farms has not been increased and Fish Seeds for all Schemes are procured from private fish farms of Assam. Some of the DFDOs are indulged in unwarranted /illegal practices in the name of procuring fish seeds by producing Bills from Hardware stores, local general stores, local contractors & shop owners of variety stores leading to leakage of Govt. /department revenue despite the infrastructure available within the district to rear spawn, carry out fish breeding operation in the Model Fish Farms. Therefore, it is to remind **all the DFDOs and concerned officers that fish seeds under all the fisheries schemes are required to be procured exclusively from Model Fish Farms/ Govt. Fish Farms of Arunachal Pradesh.** In case of non-availability of fish seeds in the Govt. Fish Farms of own district the concerned DFDO shall procure from the Model Fish Farm of the neighboring district and in case of failure to supply the fish seeds, the DFDO of the Model Fish Farm district shall have to issue a non-availability certificate to the client district for procurement of IMC & Exotic fish seeds from Govt. Fish Farms, Emchi / Lathao Fish Farm, Namsai except trout seed.
